






## EXHIBIT A TRACT# 926 TAX MAP ID# 77-32

All that certain lot, tract or parcel of land lying, situate and being in Franklin Magisterial District, Southampton County, Virginia, being a part of of the property formerly known as the Barham or Judkins Farm, and lying on the South side of the Atlantic and Danville Railroad, containing 17.50 acres, as shown on plat made by J. A. Riggins, March 1955, Scale 1" - 400', and bearing the legend - "Map Showing John T. Artis Tract of Camp Mfg. Co. Inc., Southampton County - Va", which said plat is attached to and made a part of this deed and duly admitted to record simultaneously with the recordation hereof, whereon said tract or parcel of land is more particularly bounded and described as follows:

Beginning at a point on the South side of the Atlantic and Danville Railroad, a corner for this tract and the land of C. J. Holcombe, an iron pipe, running from thence South 18° 30' East 208 feet to a point, iron pipe; thence South 34° 30' East 173 feet to a point, iron pipe; thence South 58° 45' East 449 feet to a point in Nottoway Swamp; thence along the center line of the run of a branch designated on said plat as property line, North 69° 30' East 303 feet to a point; thence South 78° 00' East 145 feet to a point; thence South 79° 30' East 339 feet to a point; thence South 42° 30' East 69 feet to a point; thence North 77° 45' East 352 feet to a point; thence North 81° 45' East 292 feet to a point; thence North 74° 15' East 194 feet to a point; thence North 88° 30' East 266 feet to a point; thence North 82° 00' East 89 feet to a point; thence North 34° 00' East 120 feet to a point; thence North 79° 30' East 71 feet to a point; thence North 70° 00' East 133 feet to a point; thence North 89° 30' East 217 feet to a point; thence North 82° 15' East 152 feet to a point in the southern boundary of the right of way of the said Atlantic and Danville Railroad Company North 86° 00' West 309 feet to a point; thence South 89° 15' West 1417 feet to a point; thence North 87° 00' West 333 feet to a point; thence North 83° 00' West 208 feet to a point; thence North 80° 15' West 1417 feet to a point; thence North 87° 00' West 333 feet to a point; thence North 80° 15' West 139 feet to the point of beginning, and being bounded on the North by the right of way of the Atlantic and Danville Railroad Company; on the East, South and West by the land of Mrs. Mary Ellen Wade, the Estate of C. W. Darden, and C. J. Holcombe.

It being in all respects the same tract or parcel of land conveyed to John T. Artis by deed from J. Edward Moyler and John C. Parker, Jr., Special Commissioners, dated May 2nd, 1947 and recorded June 11th, 1947 in the Clerk's Office of the Circuit Court of Southampton County, Virginia, in Deed Book 92, page 527, to which reference is hereby specially made for the recitals therein contained, except that therein the same is shown as 15-3/4 acres, according to survey therein referred to, whereas the above described map, made by said J. A. Riggins, shows the same as containing 17.50 acres, more or less.


