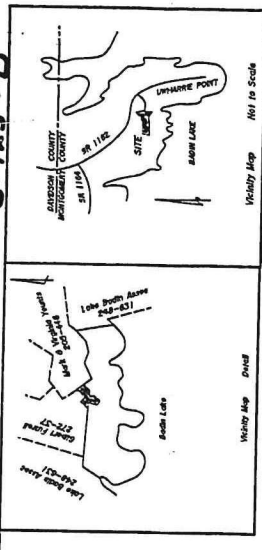
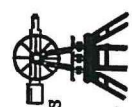

Neighborhood Map (Not to Scale)

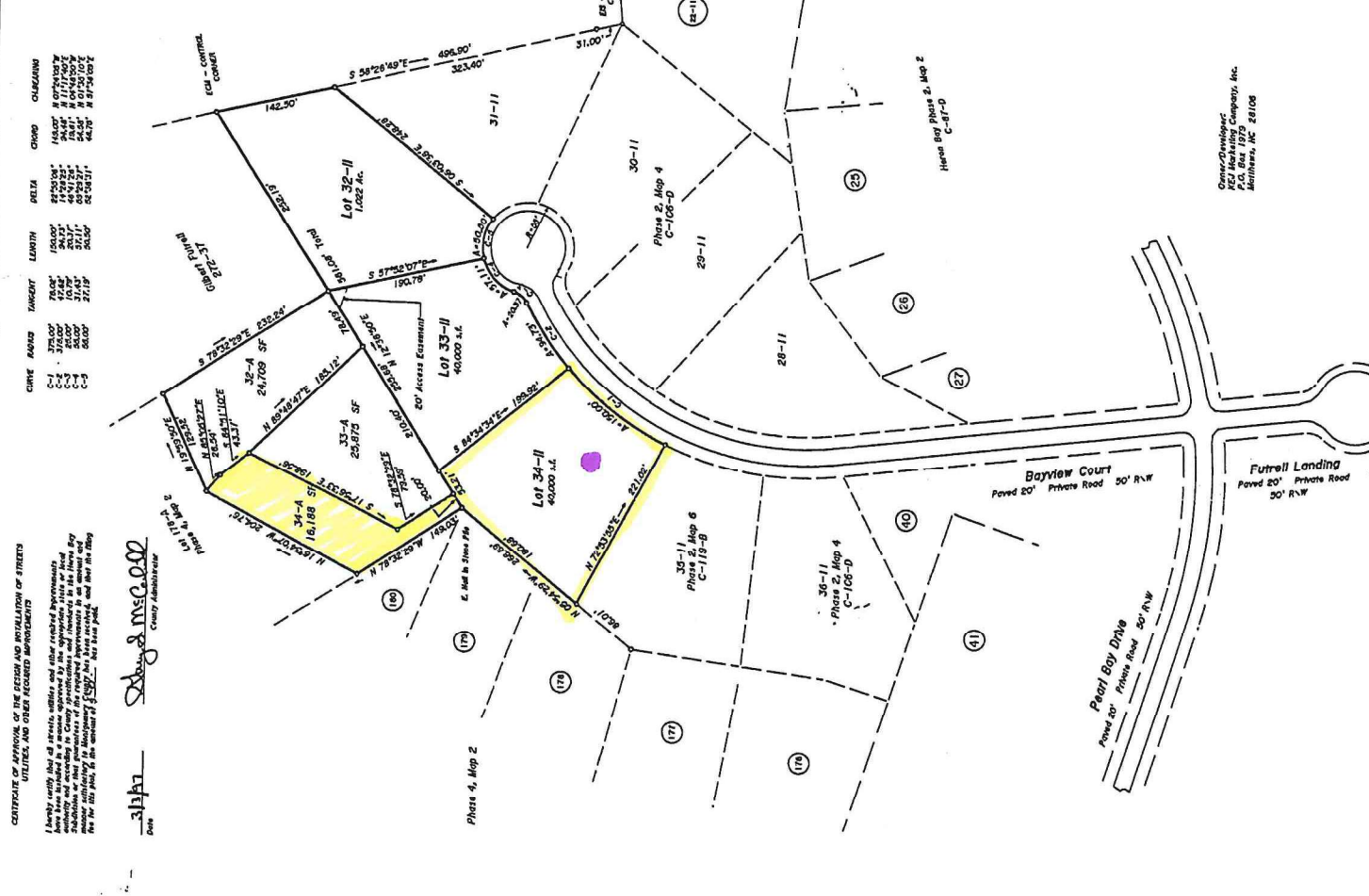
